PASTOR'S REPORT

Dear Beloved of God,

Despite another year in pandemic, the people of this church have persevered. The saints and souls of FCCE have persevered. God's grace is so amazing and allencompassing that we have all persevered and perhaps have become braver disciples. We found our way out of the box of traditional and expected worship. We have kept what works and added new things that work. Navigating pandemic has been like a dance with reluctant partner: one step forward, two steps back and just when we thought we had figured out the steps, we'd have to salsa sideways, and in a hurry. insurmountable Despite the nearly conditions we have persevered continued to be The Church. We have wept in great pain and loss and yet we rise. I couldn't be more blessed to be a part of this faith community and I couldn't be prouder when I look around and see your honest hope, your depth of courage and continued willingness to be creative and caring as we strive to be the hands and feet of Christ in this world.

- I might list off all the things that I have done this year in service to God and to God's people but in my heart keeps coming up these two truths: One, I am not sure anyone wants to read about that and two, I may have lost all sense of time in spirit and space. I am no longer sure what happened when. Sure, I could reconstruct a timeline from my date book or my prayer ledger, but rather. I think it is better for us all to leave that to the other team leaders and officers (be sure to read what they have offered). Instead, let us leave the deconstructing the past year for others and let's look forward to what we can construct together for the future. Because by God's grace, there will be a future for FCCE.
- Let's build more benches for the Thanks Be to God outdoor chapel and celebrate the gatherings of praise and worship that happen in that very movable space. As we have leaned fully into being a church that offers outside sanctuary, we have been filled. In spirit and in space we have been filled. Thank you to John Schontag, Mark Hoffman, Jeff Pelkey, Lisa Marshall and all the amazing deacons who dreamed and schemed and brought the vision to life. From our spring and summer services to

our now legendary Christmas Eve joy to the world gathering, to the weddings and funerals that have been held in that sacred holy space. Let us commit to building more benches, covering them with a sheltering tent, and bringing it all to spark with fire pits and designing a lectern for bringing the Word. Let's create non-Sunday morning options that meet the people where they are and let's rest in creation, or on the beautiful chairs that *Nate Orr* built for the community.

- Let us reconstruct the Kids Ministry of this church. As we have held online services since the pandemic first arrived, we've never wavered in offering a Message for All God's Children. In story form, interactive object lessons and now that we have returned on site, we have invited the kids to splash, celebrate, explore their faith and be critical to our community. Let us continue to construct something that teaches and reaches all ages as we have begun offering a special activity time for those young people On-site. I am hopeful to offer a holy week event and a VBS weekend. I am even dreaming of a camping event. Let us never forget the gifts they bring and the gifts they need to receive. As we construct family Sundays and worship times just for kids, let us remember that they need to learn, and we need to let them teach us.
- Let us reconstruct and reimagine the fellowship building usage. Pandemic has given us the perfect chance to be fresh in our welcome, intentional about how the space is used and what we stand for as followers of Christ when we invite others. The RENEWAL room is just about ready for usage, thanks to the Out of The Shadows project that has been long postponed but now is thriving. Andy Wormwood has been working with me, his mother Sherri, Mark Hoffman, and the Board of OOTS to create a beautiful and functional space that will be used for not only FCCE Ministry endeavors but also education, wellness and support for any and all who might need renewal. The priority will be for support for community families who are loving someone who in

recovery from substance abuse (the mission of OOTS). Mental health and group support groups, (grief, caregiving, survivors, senior ministry, play groups) will also be of key usage for the RENEWAL Room. Safety concerns have not yet allowed these groups to be defined or scheduled but we keep hope.

The space is inviting and peaceful and we hope to keep it as such. In fact, why not imagine constructing a welcoming space in the church office and the hallway as well. It all looks and feels so amazing in the RENEWAL room. Let's keep going! The rooms on the upper floor are outdated and not encouraging of inspiring work. Let's change that with renewal in our welcome, our clarity of space usage covenant and with some paint!

Let's construct and even more extravagant welcome. Now more than ever, we need to share God's incredible invitation to word and sacrament for all. It came as a surprise to many that when the wider church listed which congregations were designated Open and Affirming, that our little church with the big heart was not on it. Surely we are not only welcoming and open, we are affirming and invitational! Thanks be! Alas we have never taken formal steps to register as such with the wider church. We just did it! We walk the walk, and we talk the talk. I am often in awe how deeply inviting this congregation is. Maybe this year is the year to make it official on paper? Remember, once upon a time, when I first arrived, people were considered that we were now the "crippled church" but really we learned that we are just church. Good, honest, thoughtful, caring church who welcomes all and goes out of their way to welcome those who society has not welcomed fully. Is the following the sort of statement that represents who we are? Then let's talk! If you think it does not, then let's really talk.

Because we seek to walk in the way of Jesus, inspired to live compassionately, authentically and honestly, we at this church declare ourselves to be open, affirming and invitational. We proclaim this covenant of welcome to everyone, especially if you have known the pain of exclusion in the church and society.

Here, we have promised to be a conduit of God's love, a wellspring of spiritual growth, and a sanctuary for holy worship. Know that you will be embraced and loved for who you are. No matter your race, ethnicity, sexual orientation, gender identity or expression, family structure, faith background, mental health, physical or cognitive abilities, doubts, troubles, or economic circumstances, you are warmly invited to break bread at our communion table, to share in all the sacraments, fellowship, ministries, leadership roles, joys and sorrows of our faith community. We will journey with you. We will believe in you, encourage you to believe in your gifts and to go where you feel holy and alive as a beloved, beautiful, strong child of God.

No matter who you are or where you are on that journey, you are more than welcome here.

Let us construct a strong supportive calling and covenantal community! We are a calling church. That means that God has been calling others in our congregation to serve in ministry beyond the seats of the pew. Sandy Norris is a full Member in Discernment and has been on a sabbatical of growth and healing and still works and prayers towards ordained ministry and the hope of serving a congregation of her own. We hold Sandy in prayer. Jeffrey Pelkey is a candidate for soon being a Member in Discernment and is serving both as a first responder chaplain and the pastor of North Berwick UCC. As we are his home church. are called to provide support, relationship, guidance and a safety net as he serves and works toward authorized ministry. We have celebrated a revival with him this past year and we look towards upcoming shared ministry more

opportunities. We hold Jeff in prayer. George Salzer is feeling the call to serve beyond the pew and has been a part of the leading worship team since we returned to onsite worship. He is a candidate for being a Member In Discernment and will probably go before the York Association Committee on Ministry in the fall. He hopes to be authorized to serve this congregation as a preaching deacon who also serves pulpit supply for other congregations. We hold George in prayer. Ludia Hoffman is nearing the completion of her second year at Yale Divinity School and is working toward ordained ministry. She became a full Member in Discernment in February and has her heart set on church camp ministry with a side of parish ministry. We hold Lydia in prayer. I have the privilege of leading and teaching eight of the Members in Discernment of the York Association (MIDS) in a program I developed called MIDS on the MAP. We meet once a month together to discern paths and to guide in study. It has been lifted up by the Maine Conference as a strong ministry and I am thrilled that FCCE has such a strong presence in the process of call. I have just finished a very long (6 year) service of being the Moderator of the York Association of the Maine Conference and joyfully, that culminated with our very own FCCE hosting the Association Annual Meeting. Clergy and Laity were in great attendance, and I was deeply grateful to be a part of such a strong and healthy congregation like FCCE. I now serve as the Chair of the Committee On Ministry and have the joy of working with the clergy and the churches with the ideas of covenant, accountability and care. This is the part of our association that ordains, supports and considers concerns of behavior and boundaries of clergy. I am so proud that FCCE has such a strong covenant connection with the wider UCC.

Let's continue constructing multi-platform opportunities to reach, teach and preach.

We have learned how to have studies over Zoom, pastoral care gatherings over Zoom and worship over Zoom. Reaching people across the country and offering recorded playing of the services during the week. Way to be incredible church! You turned our tiny country church into a leading hybrid worship congregation. Thank you to all who gave to this technological mission in money, time and prayer. Thank you to all who attend and trust that online worship is real worship! Deep and abiding thanks to Mark Hoffman who has taken lead on this effort and continues to put in countless hours of volunteer time each week so it looks easy. We have also developed a strong social media presence and Lisa Marshall and I have learned how to do graphics, electronic communication and worship art and most recently have added "Pastor Talk" to great reception. Along with those recorded camera talks, we will continue to expand and explore new ways to be multi platformed in worship and work of the church.

And speaking of *Lisa...*. None of these past two years would have been survivable without her. She is invaluable. So let us continue constructing ways to support, commend and compensate her. Lisa's role in directing the fundraising team has been nothing less than spectacular. Her service as the Ministry Administrator of the congregation has proven to be flexible, courageous, and insightful. Perhaps most lifesaving, Lisa has become the best pandemic music director this side of the Mississippi. Our chapel choir. sanctuary choir and our square choir has wildly exceeded expectations and has been featured in other churches services with great joy. She is a true miracle worker. She deserves more than we could ever give her but church, we should try. Of all the places I have worshipped, of all the churches I have served and all the partners in leadership I have had, Lisa Marshall exceeds them all.

Going forward, let us construct care for one another and for ourselves. I have struggled mightily in this area, as pandemic has severely limited my face-to-face connections with our people and the need for connection is great. I need help. Please help me reach the lost sheep who are home bound, or frustrated at the masking rules, or overwhelmed with the pandemic losses. Remember that you can always call me if vou feel I haven't met a need or have forgotten a person. Remember that we are all ministers in this faith and we can all care for the flock. After all, I am always trying to empower FCCE laity so that I work myself right out of a job. You are a strong, mission minded, covenanted church with a big heart and you have been amazing! continue to persevere, the love continues to expand, the congregation continues to grow and the message of God is being shared far and near.

Never before have we been so beautiful and never before have we been so grateful. Many community members have reported back that they drive slowly by our church just to take it all in.

Be sure to enjoy the new outdoor Adirondack chairs built by *Nate Orr* and the upstairs Sunday School room, transformed by *Andy Wormwood* and friends into the RENEWAL room, for any gathering that needs it, including the Sunday school.

We give a standing ovation to the ever amazing *Al Morin* who is always first on the scene after a snowstorm and can build, repair or create anything we need for the life of the church. Most recently Al has transformed our disability ramp with new decking, and has built us a new back stairway at the parish hall lower-level exit door.

We continue to celebrate the incredible outpouring of generosity and leadership that brought the sanctuary building back to life with new siding. We are keenly aware that more repairs and building care is needed but this was a lifegiving start... and we are still admiring the new sign!

Thank you to *Lisa Marshall* who does the bulk of that work behind the scenes, and great thanks to *Bobbie Gosselin* who never shies away from a space that needs some sparkle. We appreciate the *Schontags*, the *Marshalls*, and the *Donhausers* who have always been on hand to help whenever needed and we are encouraged by the spirit to keep improving and investing in the campus for the future.

Financial Team Review

2021 was another year living with a pandemic but with many improvements! This congregation came through big time with many different fundraising efforts.

The "Thanks be to God" outdoor chapel was born last summer, and we finally were able to gather in person. This was achieved through a special donation and the carpentry skills of *Mark Hoffman* for all the benches and *John Schontag* for the altar/table.

The fundraising team worked hard to bring us many fundraising events throughout the year which brought in a total of \$19,675!! These were done safely and for the most part outside. See the report for details but some of these were; curbside meals each month, plant sale, Blueberry Festival and at the end of the year the Christmas Market happened as a hybrid – online and in person with safety modifications. Proceeds from the Christmas Market of \$5,000 were given to the Ladies Circle to continue their ministry to the church. Fundraising net amount is \$14,675 as a result.

The siding on the parking lot side and back of the church deteriorated to the point that we had to make repairs. Additional fundraising for the capital campaign happened and low and behold it was done!! We raised \$38,000 which was more than enough to cover the cost. Thank you to *Laura* and *John Schontag* for spearheading and monitoring this endeavor.

An online fundraiser happened so we could purchase the equipment needed to enhance our technology. We raised \$13,600 and have used the majority. There is still a little more equipment needed and a "desk" to be built but it enabled us to finally gather inside and be on Zoom at the same time. A special thanks to Mark Hoffman and his technical expertise. This couldn't have happened without him!

I also want to give a special thanks to *Linda Downey*, Treasurer, for her continued dedication for maintaining all the different streams of income (PayPal, Stripe, Tithe.ly and checks for all different things coming in the mail). She does an amazing job keeping it all straight. Net income stayed on track in 2021 due to everyone maintaining their pledges and even adding to them and the wonderful work of the fundraising team.

The stewardship campaign was down again this year. The total of pledges for 2022 so far is \$32,020. See the Financial Secretary's report for more details. This means expected income for 2022 is down. There are some that typically pledge that we have not heard from. If you have not sent us your pledge, please do as soon as you can. It is easy to do on our wonderful website! This helps us to determine the annual budget.
